- c. Section 610.021(3)-Hiring, firing, or promoting an employee or when personnel information about the employee is discussed or recorded;
 - d. Section 610.021(7)-Testing and examination materials, before the test or examination is given or, if it is to be given again, before so given again;
 - e. Section 610.021(9)-Preparation, including discussions or work problems, on behalf of a public governmental body, or its representatives or negotiations with employee groups;
 - f. Section 610.021(11) - Specifications for competitive bidding, until either the specifications are officially approved by the public Governmental Body or the specifications are published for bid;
 - g. Section 610.021(12)-Sealed bids and related documents, until the bids are opened; and sealed proposals and related documents or documents related to a negotiated contract until a contract is executed, or all proposals are rejected;
 - h. Section 610.021(13)-Individually identifiable personnel records, performance ratings or records pertaining to employees or applicants for employment;
 - i. Section 610.021(14)-Records which are protected from disclosure by law;
 - j. Section 610.021(17)-Confidential or privileged communications between a public governmental body and its auditor, including all auditor work product.
